### **Total Cost of Ownership:**

### **Beneficial Use:**

Member agencies will provide a report on their movement towards beneficial use. (Open)

Colonel Hooks identified a severe issue with the DoD's ability to use the system infrastructure on DoD installations due to restrictions associated with frequency conflicts primarily with State of Alaska agencies. A discussion on this issue revealed that the Department of Administration (DOA) has report on frequency problems, and that the DOA has money set aside to address these specific issues. ALMR Team member Chester Ince had been previously task as part of his Transition Management role to verify the identified spectrum conflicts and work closely with DOA and the affected user agencies to ensure quick and acceptable resolution is made for all parties concerned. The correction of the frequency issues is a required action to comply with the FCC waiver conditions. Colonel Hooks ask that a report be provided to the EC on the status of this critical action until resolved. (Open)

### **User's Council:**

Update on actions associated with establishment of and activities associated with the Users Council. Each Co-Chair to report status. Mr. Callahan will provide a user-friendly version of the major User's Council responsibilities. (Open)

### **Alaska Land Mobile Radio Communications System Cooperative Agreement**

Col. Hooks requested each member examine the cooperative agreement and have their communities of interest reviews completed by the end of June 05. Getting this document finalized and established as the core agreement for moving into and sustaining beneficial use is very important to meeting the Executive Council's stated goals of reaching Beneficial use by the end of October 2005.
